Please note that pursuant to Resolution No. 10246, among the prohibited acts include the transfer or detail of officers and employees in the civil service including public school teachers from April 14 to May 23, 2018, and the appointment or hiring of new employees, creation of new position, promotion, giving of salary increases, remuneration or privileges from May 4 to May 13, 2018.

Furthermore, Resolution No. 10211 provides for General Instructions on the composition and appointment of the members of the Electoral Boards and Barangay Board of Canvassers (BBOCs), including the process of tallying, counting, and canvassing of election results, and other matters relative thereto.

All DepEd personnel who shall be appointed as BBOCs, Department of Education Supervisor Official (DESO), and support staff are instructed to strictly observe the provisions stipulated in the General Instructions.




