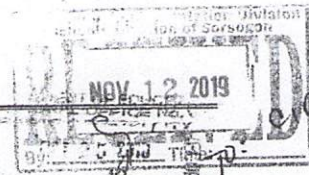

SUBJECT : **COMMEMORATION OF THE 156TH BIRTH ANNIVERSARY
 OF ANDRES BONIFACIO**

DATE : **08 October 2019**

Pursuant to the Philippine Legislature Act No. 2946, enacted on February 16, 1921, making November 30 of each year a legal holiday to commemorate the birth of Andres Bonifacio, the Department of Education (DepEd) shall celebrate the **156th Birth Anniversary of Andres Bonifacio on November 30, 2019.**

Relative to this, a commemoration ceremony shall transpire on the above mentioned date, 8:00 a.m., on different sites and venues (see Annex A). DepEd is enjoined to give full support to the commemoration of the said event. The Wreath-Laying ceremonies shall also be replicated in different cities and municipalities nationwide to be spearheaded by their respective local government units (LGUs).

Moreover, all public and private elementary and secondary schools are encouraged to undertake activities that highlight the qualities, achievements and contributions of Andres Bonifacio, the founder of the *Katipunan* and leader of the Philippine Revolution for Independence in 1896.

We also enjoin and encourage that every Region/Division/Schools carry out activities integrated into related subject areas, such as *Sibika at Kultura, Heograpiya, Kasaysayan at Sibika (HEKASI), Araling Panlipunan, Edukasyon sa Pagpapakatao (ESP) Music, Arts, Physical Education and Health (MAPEH), Filipino and English*, during classroom discussions to make this year's celebration more meaningful.
