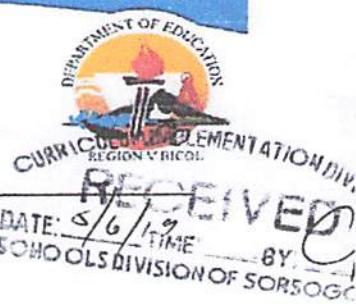

**REGIONAL WORKSHOP ON THE QUALITY ASSURANCE OF THE PROTOTYPE AND
CONTEXTUALIZED DAILY LESSON PLANS (DLPs) IN ALL LEARNING AREAS FOR
KINDER-GRADE 10**

To : Schools Division Superintendents

1. In order to ensure compliance to standards in the process of developing learning resource materials, this Office through the Curriculum and Learning Management Division (CLMD) shall conduct a Five-Day Regional Workshop on the Quality Assurance of Daily Lesson Plans (DLPs) in all learning areas for Kinder-Grade 10 which were validated and finalized at the Division Level on May 27-31, 2019 at a venue to be announced later.
2. The participants shall be the Division Education Program Supervisors of the Learning Resource Management Development System (LRMDS), Division Learning Area Supervisors in Kinder, Filipino, English, Math, Science, Araling Panlipunan, EPP/TLE, MAPEH and Edukasyon sa Pagpapakatao, and the MTB-MLE Supervisors/ Coordinators of the Bikol Central speaking divisions.
3. The workshop is a live-in activity. Part I is a plenary session on the standards in the quality assurance of the Daily Lesson Plans (DLPs) and part II is a workshop proper by learning area to be facilitated by the Regional Education Program Supervisors.
4. The concerned Education Program Supervisors and Coordinators must prioritize this regional activity. No proxies are allowed. They are advised to bring laptops and extension cords for the workshop activities.
5. Participants are expected to arrive at the venue on Day 1, May 27, 2019 at 8:00 in the morning. The first meal to be served is breakfast while the last meal is afternoon snacks of Day 5. However, participants from the island divisions (Catanduanes, Masbate City and Masbate) and Camarines Norte shall be accommodated on Day 0, May 26, 2019 with dinner as their first meal.
6. Accommodation and meals of the participants, supplies, materials and other expenses relative to the activity shall be charged against regional funds while travel expenses of all participants shall be charged against local funds/MOOE subject to the usual accounting and auditing rules and regulations.
7. Immediate dissemination of this Memorandum is desired.


