1. By virtue of the DepEd Order No. 5, s. 2014 on the Year-round Implementation of the Gulayan sa Paaralan Programs, the Division of Sorsogon will conduct a monitoring and evaluation on the implementation of Gulayan sa Paaralan Programs starting August 2019 and onwards this S.Y. 2019 -2020.

2. It aims to:
