**RE-SCHEDULING OF THE CONDUCT OF 2019 3RD QUARTER NATIONWIDE SIMULTANEOUS
EARTHQUAKE DRILL (NSED)**

1. In relation to the approved memorandum No. OUA-MEMO-12-0119-0083 "CY 2019 Quarterly Nationwide Simultaneous Earthquake Drills" and NDRRC Memorandum No. 63, s. 2019 "Conduct of the CY 2019 Third Quarter Nationwide Simultaneous Earthquake Drill (NSED)," DepEd DRRMS Director Ronilda R. Co issued an unnumbered Memorandum dated 05 August 2019 with the subject: 3rd Quarter Nationwide Simultaneous Earthquake Drill, stating that the Regional Offices and Division Offices may move the 3rd Quarter NSED for the schools to a later date in coordination with their respective Office of the Civil Defense (OCD) or the Local Government Unit (LGU).
2. In view thereof, **all schools under DepEd Sorsogon Province is re-scheduling the earthquake drill in their respective areas on Tuesday, August 13, 2019 at 2PM.** However, the SDO will conduct the 3rd Quarter NSED on August 8, 2019 at 2PM. **School DRRM coordinators must submit their reports on or before August 15, 2019 to their District/Cluster DRRM Coordinators who will consolidate the data and submit the following information on or before August 19, 2019 to the Division DRRM Coordinator: 1. Number of schools that conducted the NSED, 2. Number of participating learners and teachers, 3. Top three (3) issues and concerns encountered, 4. Top 3 recommendations, and 5. One (1) best photo. ONLY the district/cluster consolidated reports must be submitted to josephjohn.perez@deped.gov.ph.** Please refer to the attached form and the enclosed memoranda from DepEd Central.
3. Expenses that may be incurred in the conduct and monitoring of the activity shall be charged against local funds/school MOOE subject to the usual accounting and auditing rules and regulations.

SUBJECT : **3rd QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL**

In relation to the approved memorandum no. OUA-MEMO-12-0119-0083 "CY 2019 Quarterly Nationwide Simultaneous Earthquake Drills" and NDRRMC Memorandum No. 63s, 2019 "Conduct of the CY 2019 Third Quarter Nationwide Simultaneous Earthquake Drill (NSED)", the event and the quarterly periodical exam are scheduled on the same date, **08 August 2019**. As such, the Regional Offices and Division Offices may move the 3rd quarter NSED for the schools to a later date in coordination with their respective Office of the Civil Defense (OCD) or the Local Government Unit (LGU).

With this, we are requesting the Regional and Division DRRM Coordinators to inform the Disaster Risk Reduction and Management Service (DRRMS) for the new schedule and observe the following objectives:

1. To evaluate the readiness and awareness of learners and DepEd personnel on earthquakes; and,
2. To evaluate the coordination and communication mechanisms during evacuation procedures and response.

Proper documentation and post-activity evaluation of said drill are required. All field offices are advised to make necessary preparations to ensure that the required reports are submitted on time (**Annex A**).

For strict compliance.

Annex A. Guidelines for the Memorandum on the Conduct of the 2019 Quarterly Nationwide Simultaneous Earthquake Drills (NSED)

All schools, school division offices, and regional offices should thoroughly follow the guidelines below; non-compliance is tantamount to non-acceptance of said reports.

1. School DRRM Coordinators will submit the reports, pictures and videos to respective Division DRRM Coordinators not later than two (2) days after the quarterly NSED.
2. Division DRRM Coordinators will consolidate NSED reports; pictures and videos from School DRRM Coordinators and will submit only to respective Regional DRRM Coordinators copy furnish their respective Schools Division Superintendent not later than 10 days after the quarterly NSED copy furnish DRRMS through drmo+NSED2019@deped.gov.ph.
3. Regional DRRM Coordinators will consolidate NSED reports, pictures and videos from Division DRRM Coordinators and will submit to the DRRMS copy furnish their respective Regional Directors. Consolidated reports regarding the documentation and analysis of the Quarterly NSED must be submitted to drmo+NSED2019@deped.gov.ph not later than 20 days after the quarterly NSED.
4. Cut-off time for all deadlines will be at 5:00 PM.
5. Regional DRRM Coordinators should use the naming convention below for emails:
