

Pursuant to DepEd Order No. 76 s 2012 entitled Guidelines on Revitalizing Boy Scouting in Schools Nationwide and DepEd order No. 86 s 2012 entitled Guidelines on Revitalizing Girl Scouting in Schools Nationwide, this Office recognizes and promotes scouting through **SIMULTANEOUS CONDUCT OF DISTRICT ENCAMPMENT /CAMPORAL and CLUSTER BSP SCHOOL CAMPOREES /GSP ENCAMPMENTS** for Secondary on September 5-7,2019 .
2. The District Encampment /Camporal aims to :
  - a. provide a progressive ,safe and enjoyable learning environment for the Scout in order to enhance their physical ,social ,mental ,emotional and spiritual potentials ;
  - b. promote the highest quality of Scouting that is faithful to the mission, principles and methods of Scouting .
  - c. undergo projects, programs and activities that will cater to the fulfilment of the requirements of selected merit badges and scout ranks under advancement schemes ;and
  - d. develop their life skills through team building, cooperative learning ,group dynamics,creative problem solving and decision making skills .

3. Participants to the said activities must be :
  - a. Currently registered with GSP/BSP
  - b. Physically and mentally fit as certified by the Physician;
  - c. with Parental consent; and
  - d. of good moral character
  
4. In support to the operations of BSP/GSP Council Offices , all Districts, Schools and Institutional Scouting Units are directed to remit the Annual Membership Fees and Sustaining Fees at least ten percent (10%) of school's current enrolment
  
5. The District BSP/ GSP Coordinators and Institutional Heads are required to submit the detailed program of activities to the Division BSP/GSP Coordinators for approval of the Schools Division Superintendent .
