

DIVISION SCIENCE AND TECHNOLOGY FAIR 2019

1. Pursuant to DepEd Memorandum No. 113, s. 2019 and Regional Memorandum No. 90, s. 2019 Re: National and Regional Science & Technology Fair 2019, this Office will conduct the **Division Science and Technology Fair 2019 on September 30, 2019** at a venue to be announced later.
2. This Fair has the following objectives:
 - a. promote science and technology consciousness among the youth and develop culture of science research among students and teachers;
 - b. provide avenue for intellectual competitiveness in undertaking quality science research/ investigative projects; and
 - c. identify the most innovative research/ researcher who will represent the division in the Regional Science and Technology Fair (RSTF).
3. Participants in this activity are science student-researchers from secondary schools and their coaches, the Division Scientific Review Committee (SRC)/ BOJs, and the ASEP Support Staff. Enclosed are the lists of the Division Scientific Review Committee (DSRC)/ Board of Judges and the facilitators/support staff.
4. **Three (3) copies of project write-up should be submitted to the Division CID Office, c/o Ms. Sheila Viray on September 27, 2019 for the DSRC paper evaluation.** Entries should follow color coding of folder indicated below:

5. The same guidelines as specified in DepEd Memorandum No. 113, s. 2019 and Regional Memorandum No. 90, s. 2019 shall be followed. Please refer to the said issuance for your information/ reference and guidance.

Each student-researcher and coach shall be charged with a registration fee of Six Hundred Pesos (₱ 600.00) to cover expenses for the meals, contest materials, medals and certificates, token for the DSRC members / Board of Judges, and other operational expenses. The Registration fee, transportation and other incidental expenses of the participants are chargeable against STE Funds/ SEF/ Local Funds/ MOOE subject to the usual accounting and auditing rules and regulations.
