Invitation to Bid for *REPAIR AND REHABILITATION OF SCHOOL BUILDING – CY 2017 CONSERVATION AND RESTORATION OF GABALDON SCHOOL BUILDING IN GUBAT NORTH CENTRAL SCHOOL*

1. **DepEd, Schools Division of Sorsogon (Province)**, through the Division Bids and Awards Committee (GAA FY 2017)³ intends to apply the sum of **Four Million Eight Hundred Two Thousand Seven Hundred Seven Pesos and Thirteen Centavos (Php 4,802,707.13)** being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The Bids and Awards Committee now invites bids for the repair/rehabilitation of school buildings for:

2. The **DepEd Schools Division Sorsogon** now invites bids for **Repair and Rehabilitation of School Building – CY 2017 Conservation and Restoration of Gabaldon School Building in Gubat North Central School.**⁴ Completion of the Works required per school *is indicated on the table above*. Bidders should have completed, **within ten (10) years from the date of submission and receipt of bids**, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules

and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Office of the BAC Secretariat, DepEd, Schools Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00pm (office hours).
5. A complete set of **Bidding Documents** may be acquired by interested bidders on *October 26, 2017 – November 15, 2017* from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php 5,000.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.



7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 15, 2017, 8:00 am**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **November 15, 2017, 8:00 am** at **Schools Division Office Conference Hall, Capitol Compound, Sorsogon City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **Late bids shall not be accepted.**

8. **DepEd SDO Sorsogon Province** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
