**INVITATION TO BID FOR SUPPLY AND DELIVERY OF  
INGREDIENTS FOR THE IMPLEMENTATION OF  
SCHOOL-BASED FEEDING PROGRAM (SBFP) TO  
SEVERLY WASTED AND WASTED PUPILS (REBID)**

**PROJECT NO.: 17-09-003**

1. The *DepEd Schools Division Sorsogon Province*, through the *Division Bids and Awards Committee (SUB-ARO No. ROV-17-06-691)* intends to apply the sum of **One Million One Hundred Forty-Six Thousand One Hundred Ninety-Two Pesos and Fifty-Four Centavos Only (Php 1,146,192.54)** being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply and Delivery of Ingredients for the Implementation of School-Based Feeding Program (SBFP) to severely wasted and wasted pupils - Rebid*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bids and Awards Committee* now invites bids for *Supply and Delivery of Ingredients for the Implementation of School-Based Feeding Program (SBFP) to severely wasted and wasted pupils - Rebid*.<sup>2</sup> Delivery of the Goods is required *within prescribed schedule upon receipt of Notice to Proceed*.

Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules

and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *DepEd, Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below during *office hours, (8:00am to 5:00pm)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on ***October 26, 2017 – November 15, 2017*** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00**.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The *Bids and Awards Committee* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
