## **INVITATION TO BID FOR PROVISION OF CATERING SERVICES AND ACCOMMODATION FOR THE DIVISION TEACHERS INDUCTION PROGRAM 2017**

**PROJECT NO.: 17-08-005**

1. The DepEd Schools Division Sorsogon Province, through the Division Bids and Awards Committee (GAA RD FY 2017 MOOE-GAS) intends to apply the sum of **One Million Fifty-Six Thousand Pesos (Php 1,056,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Provision of Catering Services and Accommodation for the Division Teachers Induction Program 2017**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Bids and Awards Committee now invites bids for **Provision of Catering Services and Accommodation for the Division Teachers Induction Program 2017**.<sup>2</sup> Delivery of Services for this said project is required on the date of the scheduled training and contingent upon receipt of Notice to Proceed.

Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the

laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *DepEd, Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below during *office hours, (8:00am to 5:00pm)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 31, 2017 – September 19, 2017** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00***.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The *Bids and Awards Committee* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
