INVITATION TO BID FOR *PROVISION OF CATERING SERVICES AND ACCOMMODATION FOR THE 2018 DIVISION TEACHER INDUCTION PROGRAM (TIP)*

PROJECT NO.: 18-08-001

1. The *DepEd Schools Division Sorsogon Province*, through the *Division Bids and Awards Committee (Trust Fund and GAA FY 2018 MOOE Funds-GAS)* intends to apply the sum of **Two Million One Hundred Six Thousand Pesos Only (Php 2,106,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Provision of Catering Services and Accommodation for the 2018 Division Teacher Induction Program (TIP)***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bids and Awards Committee* now invites bids for ***Provision of Catering Services and Accommodation for the 2018 Division Teacher Induction Program (TIP)***.² Delivery of Services for this said project is required on the date of the scheduled training and contingent upon receipt of Notice to Proceed.

Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules

and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *DepEd, Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below during *office hours, (8:00am to 5:00pm)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 29, 2018 – September 18, 2018** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00***.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
