**Invitation to Bid for REPAIR/REHABILITATION OF CLASSROOMS UNDER CY 2019 QUICK RESPONSE FUND (QRF) BATCH 1 (SAVINGS)**

*Project No.: 19-11-002*

1. *DepEd, Schools Division of Sorsogon (Province)*, through the Division Bids and Awards Committee (GAA FY 2019)<sup>3</sup> intends to apply the sum of *Two Million Seven Hundred Eighty-Two Thousand Three Hundred Thirty-Four Pesos and Forty-Two Centavos (Php 2,782,334.42)* being the Approved Budget for the Contract (ABC) to payments under the contract. **Bids received in excess of the ABC shall be automatically rejected at bid opening.**

The *DepEd Schools Division Sorsogon* now invites bids for REPAIR/REHABILITATION OF CLASSROOMS UNDER CY 2019 QUICK RESPONSE FUND (QRF) BATCH 1 (SAVINGS).<sup>4</sup> Completion of the Works required per school *is indicated on the table above*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

<sup>4</sup> A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Office of the BAC Secretariat, DepEd, Schools Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00pm (office hours).
5. A complete set of **Bidding Documents** may be acquired by interested bidders on **November 19, 2019 – December 9, 2019** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php 5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bid opening shall be on *December 9, 2019, 10:30 am* at *Schools Division Office Conference Hall, Capitol Compound, Sorsogon City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **Late bids shall not be accepted.**

8. *DepEd SDO Sorsogon Province* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
