- The *DepEd Schools Division Sorsogon* now invites bids for **REPAIR OF CLASSROOMS/CONVERSION OF CLASSROOMS TO DENTAL CLINICS UNDER CY 2019 DENTAL HEALTH FACILITY PROGRAM.**⁴ Completion of the Works required per school is indicated on the table above. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Interested bidders may obtain further information from *Office of the BAC Secretariat, DepEd, Schools Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00pm (office hours).
- A complete set of Bidding Documents may be acquired by interested bidders on **November 20, 2019 – December 10, 2019** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php 5,000.00 for each lot.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, **provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.**


