1. *DepEd, Division of Sorsogon (Province)*, through the *Division Bids and Awards Committee* intends to apply the sum of **One Million Five Hundred Eighty Four Thousand Pesos Only (Php 1,584,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of Community/Alternative Learning Center Under Bottom-Up-Budgeting (Bub) – Innovative Programs**. Bids received in excess of the ABC shall be rejected.

2. *Bids and Awards Committee* now invites bids for **Construction of Community/Alternative Learning Center Under Bottom-Up-Budgeting (Bub) – Innovative Programs**. Completion of the Works required per school *is indicated on the table above*. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations of RA 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the Office of the BAC Secretariat, *DepEd, Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below during *office hours, (8:00am to 5:00pm)*.
5. A complete set of **Bidding Documents may be purchased from July 1 to July 13, 2016** by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 5,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) at www.philgeps.net, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
