## Invitation to Bid for *REPAIR OF CLASSROOMS UNDER CY 2020 QUICK RESPONSE FUND (QRF)*

*(Lots 4,9, 11, 22 and 32 – Rebid)*

**Project No.: 20-06-003**

1. *DepEd, Schools Division of Sorsogon (Province)*, through the Division Bids and Awards Committee (GAA FY 2020 – Sub ARO #OSEC-5-20-0384)<sup>3</sup> intends to apply the sum of *Seventeen Million Eight Hundred Thirty-One Thousand Seven Hundred Eleven Pesos and Fifty-Four Centavos (Php 17,831,711.54)* being the Approved Budget for the Contract (ABC) to payments under the contract. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *DepEd Schools Division Sorsogon* now invites bids for **REPAIR OF CLASSROOMS UNDER CY 2020 QUICK RESPONSE FUND (QRF) (Lots 4, 9, 11, 22 and 32- Rebid).**<sup>4</sup> Completion of the Works required per school *is indicated on the table above*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Office of the BAC Secretariat, DepEd, Schools Division of Sorsogon (Province), Capitol Compound, Sorsogon City* and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00pm (office hours).

5. A complete set of **Bidding Documents** may be acquired by interested bidders on **June 25, 2020 to July 15, 2020** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Php 5,000.00** each for **lots 4, 9, 11, 22 and 32**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.


