Warmest greetings!

The Department of Social Welfare and Development thru Pantawid Pamilyang Pilipino Program would like to inform you that the program conditions for Period 3 (June to July 2020) to Period 4 (August to September 2020) are still suspended which includes their compliance to education. The suspension of the program conditions is in accordance with the approved Implementing Rules and Regulations (IRR) of the Republic Act (RA) No. 11310 otherwise known as "An Act Institutionalizing the 4Ps", particularly Section 15 of Rule VIII. To wit:

"Any or all of the conditions for entitlement may be suspended by the DSWD Secretary during times of calamities, war and armed conflicts and force majeure situations in accordance with relevant laws and DSWD guidelines. In such cases, full compliance to such conditions are deemed waived and payments to beneficiaries shall be granted in full".

On concerns raised by our Provincial and City/ Municipal Operations Offices on the conduct of Brigada Eskwela and Balik Eskwela relative to the current situation, the Department assures your office of support and assistance through encouraging the involvement and participation of Pantawid beneficiaries. However, may we request that the community/ school participation of the Pantawid beneficiaries shall be voluntary and still subject for Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID) and Local Government Units protocols. Hence, school participation must not only for Pantawid beneficiaries but also for non-Pantawid parents.
