INVITATION TO BID FOR PURCHASE OF SUPPLIES AND MATERIALS FOR THE IN-HOUSE REPRODUCTION OF LOCALLY DEVELOPED SELF-LEARNING MODULES

PROJECT NO.: 21-01-002

1. The DepEd Schools Division Sorsogon Province, through the Division Bids and Awards Committee (Sub-ARO ROV-2020-10-1361) intends to apply the sum of **Eight Million Nine Hundred Sixty Thousand Pesos Only (Php 8,960,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for *Purchase of Supplies and Materials for the In-House Reproduction of Locally Developed Self-Learning Modules*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Bids and Awards Committee now invites bids for *Purchase of Supplies and Materials for the In-House Reproduction of Locally Developed Self-Learning Modules*.² Delivery of the Goods is required **Ten (10) days upon receipt of Notice to Proceed**.

Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

² A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

4. Interested bidders may obtain further information from *DepEd, Division of Sorsogon (Province), Balogo Sports Complex, Sorsogon City* and inspect the Bidding Documents at the address given below during *office hours, (8:00am to 5:00pm)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on ***January 12, 2021 to February 1, 2021*** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 10,000.00.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The *Bids and Awards Committee* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


