2ND REGIONAL RONDALLA MUSIC CAMP

1. Pursuant to the Regional Memorandum No. 07 s. 2020 dated January 14, 2020, the 2nd Regional Rondalla Music Camp will be held on February 28, 2020 to March 1, 2020 at Tabaco National High School, Tabaco City .
2. This activity aims to:
 - a. provide avenue for organized rondalla to perform before a big audience in a festival;
 - b. preserve and promote for posterity the culture of rondalla playing;
 - c. enhance skills in playing rondalla instruments;
 - d. strengthen camaraderies among rondalla players, teachers, trainers and coaches; and
 - e. procure rondalla instruments and costumes for the RETRO.
3. The participants in this activity are pupils, students, teachers and trainers of existing rondalla in the elementary and high school levels both private and public schools. Students and teachers from the Special Program in the Arts (SPA) who are majoring in Music and members of the Regional Teachers' Rondalla (RETRO) are encouraged to attend.
4. A Registration Fee of Three Hundred Pesos (Php 300.00) for each pupils/students and Five Hundred Pesos (Php 500.00) for each teacher-participants will be charged to defray expenses for the meals of the guests, technical working group, supplies and materials, training kits, handouts, certificates, awards & honorariums of trainers, venue rental, water, electricity and janitorial services of billeting quarters.


