As subject area specialists, the Education Program Supervisors shall consolidate and interpret the data/results on how far the actual skills of the learners with the expected skills for the grade level had been achieved. This initiative is meant to address the learning loss and close the gap from current skills to expected literacy and numeracy skills that would help early-grade learners progress better through the implementation of evidenced-based programs and interventions.
