In response to the official declaration of the Philippine Atmospheric Geophysical and Astronomical Services Administration (PAGASA) regarding the increasing heat index in the Philippines and its associated dangers and hazards on March 22, 2024, the Office of the Undersecretary for Operations outlines the following mitigating measures for extreme heat/ El Nino:


Key Areas	Mitigating Measures	
Learning Delivery-related	Implement shortened classes and conduct in-person classes preferably from 6-10AM (morning shift) and 2:00-6:00 PM (afternoon shift).	
	Avoid outside classroom activities. Instruct learners to limit their outside activities to avoid direct exposure to heat.	
	Implement applicable learning delivery modalities as necessary to ensure continuity of learning from suspension of in-person to other learning modalities	
	Provide technical assistance to schools implementing appropriate learning delivery modalities	
	Ensure there is sufficient instructional materials, self- learning modules, textbooks and activity sheets for appropriate learning delivery modalities	
	Ensure that there are trained teachers on appropriate learning delivery modalities	
Safety and Health-related	Ensure availability of first aid kit	
	Ensure there is enough supply of water in the school.	
	Drink plenty of water.	
	Encourage learners to bring their personal tumblers or	
	water containers in schools.	
	Develop strategies on water management/conservation.	
	Ensure electrical equipment and appliances are regularly checked to prevent faulty wirings.	
	regularly checked to prevent faulty wirings.

	Explore ventilation upgrade of classrooms and other school facilities for conducive for learning.
	Dress appropriately by wearing light, breathable clothing.
Risk Assessment and Planning	Conduct comprehensive risk assessments including health risk to understand the potential impacts of El Niño in the schools.
	Develop a Contingency Plan for El Nino/Extreme Heat to address potential threats and hazards.
IEC and Advocacy-related	Conduct orientation to parents for the impacts of El Nino and the possible implementation of ADM
	Develop/Disseminate IEC materials on El Nino. Use of local dialect is recommended.
	Conduct information dissemination e.g. health risk communication plan, announcement during flag ceremony, posting of IEC materials through social media and in schools
Monitoring	Regular updates on the daily heat index in your locality.
	Monitor the health status of learners and personnel daily

Moreover, school heads are reminded of their authority and responsibility, to suspend inperson classes and implement modular distance learning in cases of unfavorable weather environment such as, but not limited to, extreme heat which poses health risks hindering learning and productivity.

Furthermore, it is also reiterated that the teaching and non-teaching personnel shall not be required to report to work except those who are mandated to render security, safety, finance, engineering, sanitation, health, and disaster response duties. Schools, on the other hand, must always be ready to implement remote work with measured output as stipulated in DO 37, s. 2022.

In addition, Schools Division Offices, through the Schools Division Superintendents, shall monitor schools implementing the said modality and shall submit a report to their respective Regional Directors, copy furnished the DRRMS.

ADDENDUM TO DEPED MEMORANDUM NO. 21, S. 2010

- To: Schools Division Superintendents
- 1. In view of Regional Memorandum No. 121, s. 2002 re" Guidelines for Rating athletes/campus journalists and other participants in all DepED Palaro, Cultural, Academic Conferences and Contests, the following addendum are hereby issued for guidance and compliance of all concerned.
 - A. The grade/rating of athletes/campus journalists/participants in other academic & cultural endeavors during the time that they are in the delegation list assembleresentives of the school/district/regional/national level in sports, cultural and academic activities such as PALARO, Read-a-Thon, Science/Math Quests, Press Conference, and other quizzes, shall be increased but NEVER decreased in the academic and vocational subjects and shall gain more points in the event/s participated in.
 - B. All concerned (athletes/participants) should be encouraged by the school heads to attend make-up classes, submit special projects and comply with other appropriate requirements in order to avail of the aforementioned increase in their grades/rating. Failure to do so, the rating of said athletes / participants shall be retained but in no case be given failing grades in any of their subjects.
 - C. Table below shows the corresponding points (as revised) which shall be given to the pupils/students concerned after complying with the necessary requirements commensurate to the awards received, to wit:
