ADDENDUM AND CORRIGENDUM TO DIVISION MEMORANDUM NO. 27, s. 2022 (SUBMISSION OF REQUIREMENTS FOR RECLASSIFICATION OF THE QUALIFIED APPLICANTS IN THE ELEMENTARY AND JUNIOR HIGH SCHOOL)

- 1. Per MECS Order No. 1, s. 1985, the total number of Master Teacher positions should be 10% of the total number of Teachers I, II and III. 6.7% of which should be Master Teacher I and 3.3% should be Master Teacher II. Paragraph 6 of the same MECS Order states that "In cases where the percentage result is not an exact number, the number should be rounded off as one any fraction representing .5 or higher and discarding any fraction less than .5".
- 2. This office reviewed the computation of the submitted Data District Bulletin and found out that there are districts who have additional slots following paragraph 6 of the mentioned MECS Order.
- 3. Also, Bulan North and South Districts has a new computation for Master Teacher slots because there are four schools reported under Bulan South which should have been included in Bulan North.
- 4. Stated in Annex A of this memorandum are the names of the additional applicants who qualified for reclassification and the new computation of available slots for Bulan North and South Districts.
- 5. The additional qualified applicants will be given until March 7, 2022 to submit their documents.
- 6. This office is also currently reviewing the ranking results and the latest approved appointment (promotion) of all applicants and will not endorse anyone who has not
