The DepEd Schools Division Sorsogon Province, through the Basic Education Curriculum (BEC) SUB-ARO# RO-5-24-006 intends to apply the sum of Three Million Three Hundred Forty Two Thousand Forty Pesos and Only (Php 3,342,040.00) being the ABC to payments under the contract for the PROCUREMENT OF MATHEMATICS LEARNING RESOURCES (MANIPULATIVE MATERIALS) FOR ELEMENTARY, Project No. 24-09-002. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. 4. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
