- 4. The qualifications each position found this "Enclosure 2: Tabular Summary of https://bit.ly/GradeLevelQualifications Grade Level Qualifications". The SELG and SSLG positions/offices to be filled are the following:
 - a. one (1) President
 - b. one (1) Vice President
 - c. one (1) Secretary
 - d. one (1) Treasurer
 - e. one (1) Auditor
 - f. one (1) Public Information Officer
 - g. one (1) Protocol Officer
 - h. Grade Level Representatives for each grade level for incoming Grade 3 to incoming Grade 12. The number of representatives per grade level shall depend on the size classification of the school.
- 5. The Learner Government Commission on Elections and Appointments (LG COMEA) shall be the sole governing and implementing commission in managing the elections and appointments of the SELG and SSLG. It shall be an independent, non-partisan, and non-sectarian commission designated through a school memorandum, with the following composition:
 - a. CHIEF COMMISSIONER: School Head
 - b. COMMISSIONER ON SCREENING VALIDATION: Teaching or Non- Teaching Personnel not handling any learner government
 - c. COMMISSIONER ON ELECTORAL BOARD: Teaching or Non-Teaching Personnel not handling any learner government
 - d. COMMISSIONER ON APPOINTMENT: Teaching or Non-Teaching Personnel not handling any learner government
 - e. COMMISSIONER ON GRIEVANCE: Guidance Counselor or Designate, or a member of School Child Protection Committee.
- 6. A signed copy of the school memorandum pertinent to the composition of the LG COMEA and its corresponding resolution shall be submitted in a photo or PDF format on or before February 10, 2025.
