- 2.3. The mechanism of scoring are "1" if the item is fully in place. "0.5" if in place and "0" if absent.
- 2.4. At the end of each portion, add the scores per indicator. An indicator is only given a score of "1" if all its component standards score 1. A score of "0.5" and "0" in any standard will result in the indicator scoring of 0.5.
- 2.5. In the event of clarification of concern, please write it on an extra sheet of paper indication the number Indicators and Standards/Description of the item in question.
- 2.6 After filling out, please have it scanned along with extra sheet with comments/ remarks/concerns (if any).
- 3. The Self- Appraisal Checklist (SAC) serves as basis for HLI Awards and Certification.
- 4. All Secondary and Elementary Principals/School Heads are requested to accomplish the SAC-HLI to be submitted to the office of the PSDS and to be forwarded to the Division Health and Nutrition Section (OKD-HLI Division Focal) both soft and hard copies on or before March 31, 2025.
