CONDUCT OF NUMERACY ASSESSMENT FOR GRADES 1 TO 10 AND SENIOR HIGH SCHOOL LEARNERS

- 1. Articulated in (DepEd) MATATAG: Bansang Makabata, Batang Makabansa Agenda, DepEd remains steadfast in its commitment to continuously address the pressing challenges that confront the educational system focused on the learners being the heart of the curriculum implementation. This Office directs all schools in the division to administer the numeracy assessment Post Test for Grades 1 to 10 and Senior High School Learners using Albay Numeracy Tools (ALNAT) and Region V Senior High School Numeracy Tools (RV SHS NAT), respectively on or before March 28, 2025.
- 2. As enshrined in the Regional Memorandum No. 133 s. 2022, dated October 17, 2022, re: Policy Guidelines on the Regional Utilization of Albay Numeracy Assessment Tools(ALNAT) and Electronic Numeracy Assessment Tools (e-NAT) for Grades 1 to 10, the ALNAT Pre-test shall be administered on the first week of the opening of the school year (Set A) while the post-test shall be conducted two weeks before the end of the school year using parallel sets of numeracy assessment tools (Set B).
- 3. Following the procedures in the Grades 1 to 10 data reporting, the Senior High School Math Coordinator shall be the one to input the consolidated results in the system.
