The qualified applicants must submit a copy of their **lesson plan and instructional materials based on the identified indicators for the position applied for**, for review and reference of observers before the conduct of the classroom observation.
- Additionally, the demonstration of Non-Classroom Observable Indicators (NCOI) shall also be assessed after the conduct of the classroom demonstration. Qualified applicants must bring copies of their submitted **RMPS Portfolio and other Means of Verification (MOVs)**.
- Moreover, qualified applicants shall be asked to exhibit each of the NCOIs by writing down annotations to the presented/submitted artifacts/MOVs from their RPMS portfolio narrating how the MOVs facilitated the achievement of the NCOIs through the **Portfolio Annotations Form** which shall be accomplished on the spot.
- All qualified applicants for the comparative assessment shall be duly informed thru a text message tomorrow and are expected to report to the Division Office on **March 27 & 28, 2025 (Thursday/Friday) on or before 08:00 AM.**
