- b. To promote teamwork and collaboration by encouraging inclusive decision-making and developing skills to work effectively with diverse groups.
- c. To strengthen student leaders' ability to communicate clearly and effectively with peers, faculty, and administrators, both in public speaking and written communication.
- d. To train student leaders in resolving conflicts constructively, ensuring that all voices are heard and that positive outcomes are achieved for the school community.
- 4. Participants in this activity are the elected Fourteen (14) Division Supreme Elementary and Fourteen (14) Division Secondary Learner Government (SELG/ SSLG) officer and selected SELG Teacher-Advisers.
