- 3. The Division Election Task Force shall have the following functions:
 - a. Maintain an Operation and Monitoring Center to document and report all teacher and school-related issues and concerns before, during, and after elections;
 - b. Ensure that teachers are provided with and/ or referred to adequate information, technical and legal assistance in the course of the performance of their duties as members of the Election Board;
 - c. Serve as the DepEd Institutional link to volunteer organizations and individuals;
