IMPLEMENTATION OF LITERACY REMEDIATION PROGRAM (LRP)**

1. Pursuant to DepEd Order No. 010, s. 2025, titled *Guidelines for the Implementation of the 2025 Department of Education Summer Programs, and DepEd Memorandum No. 034 s. 2025 (Supplemental Guidelines on the Implementation of the Literacy Remediation Program)*, this Office, through the Curriculum Implementation Division, will conduct a Live-out **Division Training for Remediation Teachers on the Implementation of Literacy Remediation Program (LRP)** on May 14-16, 2025, at a venue to be announced later.
2. This activity aims to:
 - a. deepen participants' understanding of the theoretical framework, instructional approaches, and assessment tools underpinning the Literacy Remediation Program.
 - b. capacitate the teachers to deliver evidence-based reading interventions tailored to the needs of low-emerging learners.
 - c. empower the supervisors and school heads to effectively manage and monitor the implementation of the program.
3. The grouping and selection of the 187 identified recipient schools are anchored on the results of the End-of-School-Year (EOSY) Comprehensive Rapid Literacy Assessment (CRLA).
4. The participants in this activity are the remediation teachers, identified school heads, and Public Schools District Supervisors, as indicated in the list attached to this memorandum.
