PARTICIPATION OF SDO SORSOGON IN THE REGIONAL ASSEMBLY OF EDUCATION LEADERS (RAEL) 2025

- Pursuant to Regional Memorandum No. 00892, s.2025 dated July 14, 2025, regarding the conduct of the Regional Assembly of Education Leaders (RAEL) 2025 with the theme: "Leadership within bounds; Opportunities beyond limits" at the Legazpi City Convention Center, Legazpi City on August 26-28, 2025.
- This activity aims to provide education-leaders the opportunity to keep pace with the national and global changes/updates, inculcate and promote the value of servant and transformative leadership in the organization.
- 3. The registration fee will be collected by the Division Cashier which shall be deposited to the account of the **BASS**, **Inc. earlier but not later than August 8, 2025**.
- 5. Participants from the Division Office shall charge their registration fee and other allowable expenses such as accommodation and pier diem to the Division MOOE while participants from the schools shall charge their registration fee and other allowable expenses such as accommodation and pier diem to their respective school MOOE subject to the usual accounting and auditing rules and regulations.
