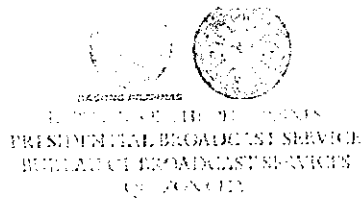
Dear Director Sadsad,

Video Guidelines

1. Must be original (no copyrighted or AI-generated content).
2. Max duration: 60 seconds (portrait 9:16, at least 720p).
3. Must begin with:
"Salamat Taxpayers! Nang dahil sa buwis _____"
-> followed by your personal experience/insight on how taxes benefit you or your community.
4. Must show the positive impact of taxes.
5. Local dialects allowed, but with English/Filipino subtitles.
6. No obscene, offensive, or inappropriate content.
7. Use the official intro and extro (provided via Google Drive).
8. Participants must FOLLOW and LIKE the official Facebook page of Radyo Pilipinas Albay and the BIR Revenue Region 10 - Bicol Region Facebook page for their entry to be valid.
