- 1. Pursuant to General Guidelines (V).c of Memorandum OM-OUPS-2024-04-01088 jointly issued by Assistant Secretary Francis Cesar B. Bringas and Undersecretary Atty. Michael Wesley Poa on February 28, 2024, with the subject: Guidelines on the Utilization of Funds for Fiscal Year (FY) 2024 Disaster Preparedness and Response Program (DPRP) Funds, this Office informs the field regarding the implementation of a regular weekly radio program with Facebook Live broadcast as an advocacy platform for Disaster Risk Reduction and Management (DRRM), Climate Change Advocacy and Mitigation (CCAM), and Project REAL (Revitalized, Efficient & Accountable Leadership) SDO Sorsogon.
- 2. This aims to serve as a platform to inform and gain support from the public on the various programs, projects and activities being undertaken by the Office of the Schools Division Superintendent (OSDS), Curriculum Implementation Division (CID) and Schools Governance and Operations Division (SGOD).

The title of the radio program is **Impormasyon At Edukasyon** which will air every Monday at 10:00AM to 11:00AM over Spirit FM (102.3MHz) with Facebook Live broadcast in social media platforms of Spirit FM and DepEd Sorsogon Province SDO. The program sequence/segment titles and the regular featured topic cycle are attached as Enclosure 1.

- Segment 3: **USAPANG EDUKASYON** discussion on DepEd PPAs/featured topic/s, etc. (Length 45 minutes)- bumper/bridge: segment #3 ID segue to segment 4 ID
