**ANNOUNCEMENT OF COMPARATIVE ASSESSMENT RESULT
REGISTRY OF QUALIFIED APPLICANTS (CAR -RQA)
FOR TEACHER I POSITION SY 2025-2026**

1. In accordance with Section 43, Enclosure 1 of DepEd Order No 07 s. 2023, this office announces the release of the **SY 2025-2026 REGISTRY OF QUALIFIED APPLICANTS (RQA)** for Teacher I position for Elementary and Secondary Levels. (*Enclosure A*).
2. In compliance with the provisions of Republic Act No. 10173, otherwise known as the Data Privacy Act of 2012 and in consonance with the provision stated in DepEd Order No 07 s. 2023, the Division Office shall use Application Codes in place of applicants' names to protect personal and sensitive information.
3. As stated in the aforesaid DepEd Order – It is deemed mandated that the RQA shall be used in filing up of new items and natural vacancies for Teacher I positions across all levels. Further, theses issuance stipulates that only applicants in the RQA are eligible for hiring and appointment.
4. Anent this, the Public Schools District Supervisors and Schools Heads are hereby enjoined to post the CAR-RQA **in three (3) conspicuous places within the district and school premises concerned**. The registry of qualified applicants can also be downloaded through the DepEd Sorsogon Province website: <https://depedsorsogon.com.ph>. The same shall also be posted in three (3) conspicuous places with the division premises, and the official Facebook page of DepEd Sorsogon and DepEd Personnel Section.
5. For queries and/or clarifications, applicants shall submit a written Letter of Inquiry addressed to CHERYLL V. BERMUDO, Assistant Schools Division Superintendent, Chairperson, Human Resource Merit Promotion and Selection Board (HRMPSB), within three (3) days from the date of posting. **The letter shall be submitted to the respective districts where the applicant lodged his or her application.** The District Sub-Committee shall compile all letters of inquiry to be submitted to the Division Office not later than **November 17, 2025**.

Official communication shall be made only through the Division's legitimate email address : ***hrmo.sorsogonprov@depd.gov.ph*** or through the Human Resource Management Office (HRMO).
7. The Division Office strictly prohibits the sale, negotiation, or influence over any teaching item. ***No teaching item is for sale, and no person is authorized to solicit or receive any form of payment, favor, or influence in exchange for appointment or placement.***
8. Applicants are strongly advised to exercise vigilance and be cautious against fraudulent or scam schemes involving alleged sale or facilitation of teaching items. Any suspicious activity or report of solicitation should be immediately reported to the Schools Division Office for appropriate action.
