**CONDUCT OF YEAR ENDER ACTIVITY OF SCIENCE-IMPLEMENTING SCHOOLS:
SCIENCE RESEARCH PROJECT SHOWCASE/FAIR**

To: Schools Division Superintendents
Division Science/Math Supervisors
School Heads of Science-Implementing Schools

1. This Office provides guidance and pertinent information on the conduct of the School-Based Science Research Project Showcase/Fair, which shall serve as the Year-Ender Activity of Science-Implementing Schools for the 4th academic quarter of School Year 2025-2026.
2. The School-Based Fair shall serve as a culminating academic activity for science implementers, providing a platform for STEM learners from the Bicol Regional Science High School (BRSHS), Legislated Science High Schools (LSHS), Science, Technology, and Engineering (STE) Program, and Special Science Elementary Schools (SSES) to showcase their inventions, research outputs, and investigatory projects (simple science projects for SSES) developed during School Year 2025-2026. All Grade 10 STE learners are required to present one completed STEM research as a program requirement. Furthermore, a repository of completed research outputs of all STE completers shall be maintained and made readily accessible at the School Research Center.
3. The indicative schedule is as follows:
-within February 9-27, 2026 (maximum of 3 days for big schools)
4. The school heads of science-implementing schools are requested to submit the schedule of the school-based conduct of the activity to the Division Science Supervisor for monitoring purposes. A copy of the consolidated schedule shall be emailed to chozara.duroy@deped.gov.ph on or before February 2, 2026.
5. Division science supervisors shall monitor the conduct of the activity and submit a documented report via the same email on or before March 30, 2026. A copy of the monitoring tool shall be sent upon receipt of the consolidated schedule.
6. Expenses related to the conduct of this activity shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
