
**REITERATION OF DEPED MEMORANDUM NO. 69 s. 2025 AND ANNOUNCEMENT
OF CONDITIONAL ACCEPTANCE OF TEACHER-IN-CHARGE (TICs) FOR NASH BATCH 2**

To: Assistant Schools Division Superintendent

1. Pursuant to Department Order No. 069 s. 2025 ***Re: Administration of the National Assessment for School Heads for Fiscal Year 2025***, This office hereby announces that in recognition of the valuable experience in school governance and operations, please be informed that Teachers-in-Charge (TICs) who participated in NASH Batch 1 and were assessed with a Competency Status of "With Developmental Needs" are now allowed to take NASH Batch 2 even not meeting the QS.
2. Accordingly, this serves as an update to DepEd Memorandum No. 097, s. 2025, particularly Item No. 6, which previously provided that only Head Teachers (HTs) and Assistant School Principals (ASPs) may be allowed to retake the assessment.
3. All eligible retakers are required to reapply using their LMS NASH Account, the following guidelines relative to the administration of FY 2025 NASH Batch 2 may be accessed through this link [FY2025NASHBatch2 - Google Drive](#)
4. Applicants for Batch 2 under the aforesaid TIC category and those tagged as "RE-APPLY" must duly resubmit the required documents on or before February 13, 2026. Non-submission of the required documents shall mean forfeiture of the slot to take the examination. Please be reminded of the following schedules, to wit:

Submission of the Final List of NASH Takers by RO-HRDD to BHROD-HRDD	on or before February 20, 2026
