1. In reference to Regional Memorandum CLMD-2026-0101 dated April 24, 2026, re: Institution-Based Summer Training Program (IBSTP) for Multigrade Teachers (Batch 2026-2027), DepEd Sorsogon Province identifies the most qualified teacher scholars.

2. The Institution-Based Summer Training Program (IBSTP) aims to enhance the competences of multigrade teachers, particularly those assigned in the last mile school.
