Club and shall assist in the conduct of the adopted school's trainings and activities. The adoptive school and the adopted school shall execute a document mentioning the adoption and shall be signed by the school heads of both schools as the adoptive school and adopted school respectively. A special award shall be given to the top three (3) adoptive schools.
- 4. An award shall be given to the top three (3) New Implementers. A school, which had joined in the previous selections for the National Search for the Outstanding W.A.T.C.H. Schools but had not participated in any selection after 2016 may qualify for this award.
