3. PSDSs/OIC-PSDSs and School Heads must ensure that the conduct of this activity shall be held with **no disruption of regular classes**, pursuant to DepEd order No. 9 s. 2026. Furthermore, it complies with **DepEd Order 32, s. 2019, Section C item 2.F(i)** which states that *"All personnel inside the school shall be unarmed and wear the prescribed uniform for activities. (i.e. Type B or Type C),"* guaranteeing a safe and secure environment that respects schools as Zones of Peace. If necessary, participants are requested to submit parental consent/permit to participate in the said activity.
