1. As per Regional Orientation on the Nestle Wellness Campus Program (NWCP) held last July 19, 2022, the implementation of the program will be conducted from July 1, 2022 to April 30, 2023 in all schools, both elementary and secondary. This is in partnership with the implementing group, the Greatfil Team, Inc. (GTI).


