**ASSESSMENT OF LEARNING MECHANISM FOR
SDO SORSOGON PROVINCE**

To: Assistant Schools Division Superintendent

1. Relative to the implementation of DepEd Order No. 8, s. 2015 re: Policy Guidelines on Classroom Assessment for K to 12 Basic Education Program, this Office shall implement the Assessment of Learning Mechanism for School Year 2022-2023.
2. This activity aims to:
 - a.) come up with the Division Literacy and Numeracy Profile;
 - b.) gather baseline data on assessment of learning;
 - c.) analyze data gathered;
 - d.) propose appropriate intervention activities; and
 - e.) improve learning outcomes of pupils/students.
3. PSDSs/OIC-PSDSs are tasked to consolidate the pre and post-test results and be submitted to the Curriculum Implementation Division (CID), Attention: Dr. Manuel V. Estera, Division Coordinator for Learning Assessment, immediately after the conduct of the assessment for the following: a.) Eight-Week Curriculum; b.) CRLA; c.) Revised Philippine Informal Reading Inventory (Phil-IRI); and d.) ALNAT for Grades 4-6 and Grades 7-10.
4. The Division shall conduct an assessment test for the Junior High School students per subject area, per grade level on a quarterly basis, using random sampling. Likewise, learners from Senior High Schools shall also be tested through their core subjects per semester.


