Subject: **REGULAR MONTHLY REPORTING OF COVID VACCINATION DATA**

1. In support of the overall vaccination drive of the national government to provide additional layer of protection to DepEd personnel and also in preparation for the implementation of face to face classes, the Department of Education (DepEd) and National Task Force (NTF) on COVID 19 agreed to accelerate the vaccination of teachers and non-teaching personnel.

2. Further, this Office also encourages all teaching and non-teaching personnel including job orders to take their COVID vaccination in their respective local Resbakuna schedule and report their vaccination status regularly, vaccinated or unvaccinated to their office or school focal person.

3. The DepEd Task Force COVID-19 (DTFC) and the Office of Undersecretary for Field Operations (OUFO), jointly issued DTFC Memorandum No. 513 which provides an updated template for regular monthly reporting of COVID Vaccination Data as attached in **enclosure no.1** (District Summary Consolidation on Vaccination Data). The district shall submit the consolidated template to SDO Health Section through their district nurses on **October 29, 2021** for this month and every **last Friday of the month** henceforth, copy furnished the sdohealthsorprovince@deped.gov.ph(email).

4. Likewise, all Elementary and Secondary Schools shall submit to the office of the Public Schools District Supervisor, their monthly updated COVID Vaccination
