MECHANICS FOR ORAL PRESENTERS

1. All oral presenters must be from those who chose to submit their completed research as a response to the Call for Entries through Division Memorandum number 181 series of 2022 issued last September 21, 2022.
2. Entries are categorized as either (1) Action Research or (2) Basic Research.
3. Oral Presenters for both categories are given a maximum of 15 minutes to discuss the following:
 - A. Introduction (including the intervention/ innovation/ strategy)
 - B. Methods
 - C. Results and Discussion
 - D. Status of Implementation/ Rollout
4. The question and answer for each presenter will last for a maximum of 10 minutes as well. Judges will be given the priority to ask questions and if the time allows, participants may be given an opportunity to ask questions to the presenters.
5. A pdf copy of the Abstracts shall be available in a google drive folder with the link to be made available to all participants during the event.
6. The **“Best Action Research”** award shall be given to the presenter who will receive the highest ratings from the judges using the following criteria:
 - A. Impact of the Action Research (40%)
 - B. Implementation and Rollout (20%)
 - C. Questions Answered (20%)
 - D. Overall Presentation of the Study (20%)
7. The **“Best Basic Research”** award shall be given to the presenter who will receive the highest ratings from the judges using the following criteria:
 - A. Integrity of Results of the Study (40%)
 - B. Dissemination and Advocacy (20%)
 - C. Questions Answered (20%)
 - D. Overall Presentation of the Study (20%)
8. The awardees for “Best Action Research” and “Best Basic Research” shall be announced during the closing ceremonies.

MECHANICS FOR POSTER PRESENTATIONS

1. All poster presenters must be from those who chose to submit their completed research as a response to the Call for Entries through Division Memorandum number 181 series of 2022 issued last September 21, 2022.
2. Entries are categorized as either (1) Action Research or (2) Basic Research.
3. A PDF copy of the abstract of the study and the implementation report will be available for download upon scanning the QR Code printed on the poster.
4. Printed posters will be judged during the First day of the Research Forum. Presenters must be present to answer questions from the judges.
5. The **Best Poster Presentation** will be chosen with combined ratings from the judges (70%) and the participants (30%). The judges will rate the poster presentations with the following criteria:
 - A. Impact of the study (50%)
 - B. Status of the Implementation (35%)
 - C. Overall design (15%)
6. Participants may be able to vote for one poster presenter for the award by accessing the link: https://bit.ly/DERF_voting using their official DepEd email account. The voting platform will be available starting Day 1 and will close by Day 4 of the Division Education Research Forum.
7. There will be separate 'Best Poster Presentation' awards for the two categories: (1) Action Research and (2) Basic Research
8. The awardees shall be announced in the closing program.
