<b>a. BRIGADA ESKWELA PARTNERSHIPS ENGAGEMENT ACTIVITIES</b> <i>This pertains to the kind/ impact of partnership engagement activities which may be measured in terms of the number of learners/ teachers/ non-teaching personnel who benefited from the activity (ies).</i>	40%
<b>b. RESOURCES GENERATED RELATIVE TO THE NEW BRIGADA ESKWELA FRAMEWORK</b> <i>This pertains to the resources generated to support the BE-LCP implementation and health and safety protocols.</i>	30%

c. Creativity and Innovations on School Preparation Activities	30%


