DepEd, Schools Division of Sorsogon (Province), through the Division Bids and Awards 1. Committee (GAA FY 2023 - OSEC-5-23-1802)³ intends to apply the sum of Eighteen Million Eight Hundred Ninety-Seven Thousand Two Hundred Seventy-Six Pesos and Ninety-Eight Centavos (Php 18,897,276.98) being the Approved Budget for the Contract (ABC) to payments under the contract. Bids received in excess of the ABC of each school for every lot shall be automatically rejected at bid opening.

- 2. The DepEd Schools Division Sorsogon now invites bids for CY 2023 CONSERVATION AND RESTORATION OF GABALDON BUILDING AND OTHER HERITAGE SCHOOL BUILDING. 4 Completion of the Works required per school is indicated on the table above. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

4 A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 5. A complete set of **Bidding Documents may be acquired by interested bidders on September 5, 2023 to September 25, 2023** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the **amount of Php 25,000.00.**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, **provided that bidders shall pay** the applicable fee for the Bidding Documents not later than the submission of their bids.
