- This is to announce to the field that this Office through the Division Human Resource Merit Promotion and Selection Board (HRMPSB) will conduct a comparative assessment for all interested Teacher I in the Senior High School.
- 2. There are forty-seven (47) new Teacher II items for Senior High School allotted to DepEd SDO Sorsogon and this Office made the resolution that Senior High School teachers who are currently occupying Teacher I positions be given the chance to be promoted to Teacher II.

- 4. **DepEd Order No. 66, s. 2007** is the reference for the comparative assessment and will be used as guide for the computation of points.
- 5. Two sealed envelopes are required to be submitted; the contents of which are as follows:

#### a. First Envelope (for pre-assessment)

- Transcript of Records for Baccalaureate and Masteral and/or Doctoral Studies or certification of units earned in Masteral and/or Doctoral Studies;
- ii. Service Record;
- iii. Photocopy of Certificates of Trainings;
- iv. Photocopy of PRC License

### b. Second Envelope (for ranking purposes)

- i. All relevant documents to be assessed during deliberation. (e.g. IPCRF for the last three years; Certificates of Trainings; Outstanding Accomplishments (Meritorious Accomplishments).
- 6. Prompt **initial evaluation** will be conducted upon submission so that the applicants will immediately know if they are qualified to proceed with the comparative assessment.
- 7. The deadline of submission is on September 9, 2023 (Saturday) at 3:00 P.M. It is therefore understood that no additional documents shall be accepted after the deadline. It is encouraged that applicants should submit their envelopes before the set deadline.
