INVITATION TO BID FOR PURCHASE OF NUTRITIOUS FOOD PRODUCT COMPONENT FOR THE IMPLEMENTATION OF SCHOOL BASED FEEDING PROGRAM

- 1. The DepEd Schools Division Sorsogon Province, through the FY 2021 GAAAO Sub-ARO No. OSEC-5-23-0689 and RO-5-23-0373 intends to apply the sum of Twenty-Eight Million Five Hundred Seventy-Four Thousand Six Hundred Forty Pesos (Php 28,574,640.00) being the ABC to payments under the contract for PURCHASE OF NUTRITIOUS FOOD PRODUCT COMPONENT FOR THE IMPLEMENTATION OF SCHOOL BASED FEEDING PROGRAM, Project No. 23-09-002. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DepEd Schools Division Sorsogon Province now invites bids for the above Procurement Project. Delivery of the Goods is required by Fifteen (15) days upon receipt of Notice to Proceed. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from *DepEd*, *Schools Division of Sorsogon (Province)*, *Balogo Sports Complex*, *Sorsogon City* and inspect the Bidding Documents at the address given below during *office hours*, (8:00am to 5:00pm).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on September 12, 2023 to October 2, 2023 from the given address and PhilGEPS website and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos Only (Php 10,000.00) per lot. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person not later than the submission of their bid.
