Greetings from the Department of Information and Communications Technology (DICT)!

The DICT, created through Republic Act 10844 "An Act Creating the Department of Information and Communications Technology" in 2016, is mandated to be the primary policy, planning, coordinating, implementing, and administrative entity of the Executive Branch of the government that will plan, develop, and promote the national ICT development agenda.

Through its ICT Literacy and Competency Development Bureau (ILCDB), the DICT professionalizes government ICT human resources through the development of national ICT competency standards, competency certification, personnel qualification standards, and career pathing, at par with the international workforce. The Bureau is currently implementing programs that follow a framework called A-B-C-D which stands for Assess, Build, Certify, and Develop. The program aims to (A) assess the competencies of individuals with regard to their digital skills based on the National ICT Competency Standards (NICS). The result of the assessment will determine (B) individuals who need further training or capacity-building on identified areas of deficiency, (C) individuals who are ready for the certification test, and (D) To further enhance their competency through additional training or certification.

Part of these programs is the International Computer Driving License (ICDL). ICDL is an international standard on end-user computer skills. It is a certification in the practical use of computers and computer applications and was conceptualized to address the growing need for digital competence in the workforce across the globe. The interested applicant/examinee may undergo the User Assessment to assess his/her knowledge of the basic office productivity tools, particularly Word Processing, Spreadsheet, and Presentation. This is good for two (2) hours while the online using the Google form is good for two and a half (2 1/2) hours. The results of this Assessment are categorized as Needs Review, Needs Training, and Proficient.

- If the examinee passes the ICT User Assessment (Proficient), he/she may proceed to the ICT User Certification.
- If not, he/she will be advised to undergo a review or training course prior to the Certification Examination.

The training to address the competency gap as recommended from the Assessment can be done through self-learning, a training provider, or ILCDB-developed training which is tailored to the needs of the individuals. Also, the examinee who is confident enough may opt not to take the Assessment and may directly take the ICT User Certification Examination.

The Certification Examination, on the other hand, is a hands-on examination using the office basic productivity tools of the ICDL. This is offered for the passers of the User Assessment and to those who are confident enough with the said office tools. This is an online examination for forty-five (45) minutes. This can only be done through an Accredited Test Center (ATC). As one of the ATCs in the Philippines, the DICT may serve as a testing site for certification-ready individuals.

In view of this, the Bureau through the DICT Regional Office and the Provincial Operations Office of Sorsogon would like to collaborate with you in this program by conducting an ICT User Assessment for ten (10) of your personnel on **October 25, 2023**.
