2023 Provincial Consumerism Challenge for Junior High School Students (Quiz Bee)

October 16, 2023 @ 2:00 - 5:00 PM SM City- Sorsogon, Balogo, Sorsogon City

MECHANICS

A. Qualifications

- Participants must be currently enrolled junior high school students of the school (private or public) they are representing. Only one team composed of two members can represent the school. For each team, one coach must be assigned.
- 2. Students must be Filipino citizens and currently residing within Sorsogon.
- 3. Any team member must not have been a contestant in the previous years' Consumerism Challenge.
- Alternate contestant will only be considered only if one of the official team members will not be able to participate on the date of the contest – provincial elimination.

B. Registration

- Contestants/Schools concerned must express their desire to join by filling up the entry forms.
 Completely accomplished forms may be personally submitted by the school's authorized representative to DTI- Sorsogon Provincial Office or thru DTI-Sorsogon Facebook Page on or before October 12, 2023.
- 2. No registration fee will be collected from the participants.

C. Coverage

- 1. The Consumer Act of the Philippines (RA 7394) and its implementing rules and regulations
- 2. Price Act (RA 7581) as amended and its implementing rules and regulations
- 3. Standards Law (RA 4109) and its implementing rules and regulations
- 4. Tobacco Regulation Act (RA 9211) and its implementing rules and regulations

D. Quiz Bee Proper

- Members of the team should bring their valid school IDs upon registration for identity verification and must wear school uniform at the time of the contest.
- Each contestant shall be provided with a QUIZ BEE ID before the contest proper for ready identification. Participants must be at the venue thirty (30) minutes before the start of the contest.
- There will be a total of twenty (20) questions which shall be in the following forms and with its corresponding points:

True or False – 1 point
Multiple Choice – 2 points
Identification – 3 points

- 4. The time limit to answer each question will be five (5) seconds for 'True or False' and 'Multiple Choice' while ten (10) seconds for 'Identification.' The question will be read twice. The contestants are allowed to start answering while the question is being read.
- 5. Immediately after the time has expired for each question, the contestants should raise their answer sheets for the judges/contest hosts to see. The contestants shall raise their answer sheet upon hearing the buzzer signaling that time is up. Failure to do so will disqualify the contestants for that particular question and will not be given any points even if the contestants' answer is correct. Contestants can no longer change the answer once the answer sheet is already raised.
- 6. The contestants must write their answers on the Answer Sheets provided by the organizers and shall be required to answer using CAPITAL LETTERS only. ABBREVIATIONS will not be allowed except for RA Republic Act, DAO Department Administrative Order and abbreviations of the names of different Philippine government agencies and instrumentalities. Wrong spelling renders the answer wrong.
- Protests shall be raised to the panel of judges before the next question is read. Otherwise, it will not be entertained. Only the contestants and the official coaches are allowed to raise a protest.
- The top three (3) teams that accumulate the most number of points after the twenty (20) questions shall be declared First Placer, Second Placer and Third Placer, respectively.
- In case of a tie, three (3) tie breaker questions shall be asked with each question worth one
 point. However, if the tie still exists, a 'sudden death' question shall be asked and the first contestant who answers it correctly shall be considered winner.
- 10. Winners shall be announced and awarded immediately after the competition. The provincial first and second placers will qualify to join the final round which will be held on 23 October 2023 in Legazpi City.
- 11. Judges' decisions are final.
- Each participating student including the teacher-coach shall receive a Certificate of Participation.
- 13. Winners will receive the following prizes:

Provincial Elimination:

1st Place – P4,000.00 plus certificate 2nd Place – P3,000.00 plus certificate 3rd Place – P2,000.00 plus certificate P300.00 for non-winning teams

Final Round (Regional Level): Champion -

P12,000.00 plus plaque

1st Runner Up – P8,000.00 plus plaque 2nd Runner Up – P5,000.00 plus plaque P2,000.00 for the non-winning teams
