1. Recognizing the importance of folkdance as a dance that reflects the life of the people of a certain country or region and as a way to express, share and connect with their own traditional culture, this Office through the Curriculum Implementation Division (CID) will hold a **3-Day Division Seminar-Workshop in Folkdancing on November 15-17, 2023 for schools in the First Congressional District and on November 22-24, 2023 for schools in the Second Congressional District at Balogo Sports Complex Gymnasium, Balogo, Sorsogon City.**

2. The activity aims to:

- a. provide opportunities for teachers to enhance their skills in folk dancing;
- b. learn some of the different folkdances from Bicol and other regions; and
- c. organize pupils and teachers dance troupe for future competition.

Other incidental expenses to this activity can be charged from other sources of funds subject to the usual accounting and auditing rules and regulations.
