OPERATIONALIZATION OF DepEd SORSOGON DIVISION EXTENSION OFFICE (DESDEO)

- 1. The **DepEd Sorsogon Division Extension Office (DESDEO)** located at INACT Complex, San Pedro, Irosin, Sorsogon is fully operationalizing its services under the supervision of the undersigned.
- 2. The **DESDEO** shall cater to the needs of the schools and districts from six (6) municipalities namely, Juban, Irosin, Bulusan, Sta. Magdalena, Matnog, and Bulan as well as other offices/ districts who might choose to avail services at the extension.
- 3. The **DESDEO** has four personnel:

OIC-Administrator – shall act as the focal person and herewith supervise, monitor, and engage in the particular operations of the extension office and shall also ensure that the systematic flow of the operation is devoid of inaccuracy and erroneous elements.

Officer of the Day (OOD) – will be assigned on a rotation basis and shall assist the OIC-Administrator with administrative tasks and incidents that require immediate attention.

The concerned Head Offices at the SDO shall immediately include in the Division Programs the operationalization of the DESDEO and shall therefore provide from the Annual Budget the necessary funding needed for its operational expenses as subject to the usual accounting and auditing rules and regulations.
